- **General information:** Remove affected person from source of exposure.
- **After inhalation:**  
If unconscious place patient on their side in the recovery position and ensure they are breathing. Clean nose and mouth with water. Artificial respiration may be administered by suitably qualified first-aiders. Get medical attention if symptoms persist.
- **After skin contact:**  
Remove contaminated clothing and shoes. Wash skin thoroughly with soap and running water. Take especial care to clean folds, crevices, creases and groin. Get medical attention. Launder clothing and clean shoes thoroughly before re-use.
- **After eye contact:**  
Check for contact lenses which must be removed from the eyes before rinsing. Promptly rinse eyes with plenty of clean water while lifting the eyelids. Continue to rinse for at least 15 minutes.
